Lynda Mann served in the United States Army for 26 years. Lynda, her husband, Bill Hall, and their son, Doug Hall, all retired colonels, have a combined 84 years of service.

Lynda was destined for a life of service. Her Father and 3 Uncles served in WWII. When the time came for Lynda to enlist, she met with an Air Force Recruiter who set Lynda on a path of selfless service to both her country and community. Rather than meet his monthly quota to recruit a female, he recommended that she talk to an Army Recruiter because with only 2 years of college the Army could offer her Officer Candidate School much sooner. Lynda joined the United States Army in 1972 as a Private and entered Officer Candidate School (OCS) 2 years later. Upon her retirement Lynda had finished her bachelor's and master's degrees and was All But Dissertation for her PhD.

During her military career Lynda gained the reputation of being a conflict resolution expert. A few of her most proud roles included:

- 1. Assigned to the National Guard Bureau Lynda served on a team tasked to create a pilot program helping youth at risk, which became the "National Guard Youth Challenge Program." This 20-week residential/1-year post-residential highly successful program is still in operation today with over 200,000 graduates nation-wide.
- 2. The Army assigned Lynda to Turkey to help resolve communication, cultural and language issues within a communications unit made up of U.S. Air Force and Turkish Army personnel. Lynda's innovative solutions included "Gateway" language programs that included technical terminology, and training to impact interactions and communications that were more respectful to the Turkish and American cultures.
- 3. Lynda was asked to a joint U.S. cold stores facility with German floor workers to resolve excessive spoilage of perishables food. Lynda took her German American dictionary (she spoke only basic German) to collaborate with the German workers who best understood the issues and resolutions. Together they developed a comprehensive plan resulting in a savings of \$1M in the first year.

After retiring in 1997 Lynda became a successful consultant helping commercial clients with government contracting as well as managing a successful executive coaching business.

Service is the cornerstone of who she is, be it working with children, raising money for local charities or serving on community boards and committees. Lynda has been awarded Lifetime Achievement Awards from the March of Dimes and the State of Maryland.

Kent has dedicated decades of service to the Aiken community, having served on both the City of Aiken Planning Commission and Energy and Environment Committee. He holds a Ph.D. in educational leadership from the University of South Carolina, an M.S. in zoology from Southern Illinois University and a B.S. in ecology from the University of Illinois.

### Reminder from MOAA National



Reminders from national MOAA to remain non-partisan in everything concerning MOAA

Partisan Political Activities: As organizations exempt from federal taxation under Sec. 501(c)(19) of the Internal Revenue Code, MOAA and its affiliates must take care to avoid engaging in partisan political activities. Under IRS rules, we are prohibited from directly or indirectly participating in, or intervening in, any political campaign on behalf of (or in opposition to) any candidate for public office.

Divisive Social Issues: We are all aware of the divisive nature of the debate over today's leading social issues – protesting during the national anthem at sporting events, racial justice, public protests, and the conduct of law enforcement officers. These are issues over which many Americans have deeply held, but differing, personal beliefs. This is also true within the military community among the ranks of active duty and retired officers and within MOAA itself.

MOAA leaders have an obligation to keep this in mind when communicating on behalf of MOAA or its affiliates. Suggesting that MOAA only supports one side of a deeply divisive issue sends a message to those with a different belief that MOAA is not for them. #### MOAA-Backed Change Will Preserve Improvements to the VA Experience

A new law will secure a stronger voice for veterans, caregivers, families, and survivors in how the VA delivers care and benefits.

The <u>Veterans Experience Office (VEO)</u>, created in 2015, helps VA beneficiaries navigate the department's complex health care and benefits systems. Over the past decade, the office has improved veteran trust in VA services through better digital access, more responsive feedback channels, and more accountability across the department.

MOAA supported standalone legislation, first introduced in the <u>118th Congress</u>, to make this office permanent. A <u>Senate bill signed Aug. 14 by the president</u> includes this provision, known as the <u>Improving Veterans' Experience Act</u>.

By codifying the VEO, Congress ensures its permanence within the VA and strengthens its authority: The office is now formally housed in the VA Office of the Secretary, led by a chief veterans experience officer, with clear mandates to oversee metrics, policies, and feedback-driven improvements across the department.

### Eligibility for burial in a VA national cemetery

Veterans, service members, and some family members may be eligible for burial in a VA national cemetery. Find out if you, or a person you're planning a burial for, can get this benefit.

### Who's eligible for burial in a VA national cemetery?


Veterans, service members, spouses, and dependents may be eligible for burial in a VA national cemetery, as well as other benefits, if they meet one of these requirements.

One of these must be true:

- The person qualifying for burial benefits is a Veteran who didn't receive a dishonorable discharge, or
- The person qualifying for burial benefits is a service member who died while on active duty, active duty for training, or inactive duty for training, or
- The person qualifying for burial benefits is the spouse or surviving spouse of a Veteran (even if they remarried after the Veteran's death), or
- The person qualifying for burial benefits is the minor child of a Veteran (even if the Veteran died first) or, in some cases, the unmarried adult dependent child of a Veteran
